Dear Mr. Davis:

I have recently spoken with Mr. Martin Barash, an attorney with Klee, Tuchin, Bogdanoff and Stem LLP. According to court records, Mr. Barash served as bankruptcy counsel for International Exchange Communications, Inc. d/b/a IECOM. I was seeking his assistance regarding the termination of registration of International Exchange Communications, Inc. d/b/a IECOM as an intrastate interexchange telecommunications company in Florida. Staff is aware that IECOM filed for Chapter 11 bankruptcy and has liquidated most, if not all of its assets, no longer provides telecommunications services in Florida, and according to Mr. Barash, will not be providing any telecommunications services in the future. Mr. Barash advised me to contact you regarding IECOM's registration in Florida.

It appears that IECOM has no reason to retain an active registration with the Florida Public Service Commission. Plus, it would be beneficial to the Commission if you were to request IECOM's removal from the registry due to bankruptcy. Because IECOM is still actively registered, staff continues to mail an annual Regulatory Assessment Fee form and delinquent notices to Burlingame, California. Obviously, this is a waste of time and resources as the offices in Burlingame are closed.

As an officer of the company, you may request that the Commission remove IECOM from the registry. To accomplish this, we need a signed letter from you which contains the following information:

1. Company Name: International Exchange Communications, Inc. d/b/a IECOM
2. Registration Number: TJ184
3. Request: Removal from the registry effective immediately due to bankruptcy and cease in operations.
4. Customers: IECOM serves no customers in Florida.
5. Regulatory Assessment Fees: IECOM requests that the Commission write-off the regulatory assessment fees as IECOM has no financial assets.
6. Bankruptcy Case No.: SF 00-33019 DM, United States Bankruptcy Court Northern District of California, San Francisco Division.

Dear Mr. Barash:

I hope that you will be able to assist me. I got your name from the US Bankruptcy Court, Northern District of California, San Francisco's Voice Case Information System, which advised you are the attorney for the above debtor.

Our records show that International Exchange Communications, Inc. d/b/a IE Com holds IXC Registration No. TJ184 and CLEC Certificate No. 4852 and that it filed for Chapter 11 bankruptcy protection on January 4, 2001. The company owes the 2002 and 2003 Regulatory Assessment Fees, along with statutory late payment charges for the years 1999, 2000, 2002, and 2003 for its IXC registration and owes the 2000 and 2003 Regulatory Assessment Fees, along with statutory late payment charges for the years 1997, 2000, and 2003 for its CLEC certificate. It appears that only the 2000 Regulatory Assessment Fee (CLEC certificate) would be considered pre-petition debt. The Regulatory Assessment Fee continues to accrue until a registration is cancelled. For example, the 2004 fee will become due January 30, 2005, for both.

I also researched the Florida Department of State, Division of Corporations' records and found that the company's d/b/a name, IE Com, expired on December 31, 2003. This means that the company must have IE Com renewed with the Florida Department of State if it wishes to keep its IXC registration and CLEC certificate active.

I would appreciate your review of this information and let me know the company's intention to continue to provide service in Florida by August 6, 2004.

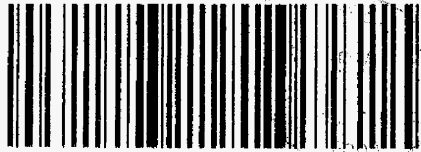

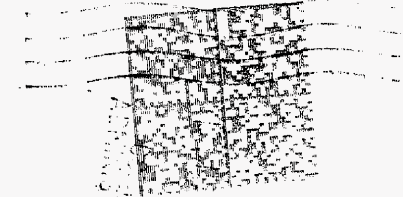

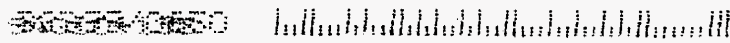

The Division of the Commission's Clerk and Administrative Services has forwarded your account to our office to address the nonpayment of the Regulatory Assessment Fees (RAFs) required by Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code, for the year 2003, which was due January 30, 2004. The RAFs return form was mailed to you on **December 15, 2003**, and to date, Commission records reflect that payment has not been received.

According to Florida Law, you are required to add interest charges at 12% per annum, and a 5% penalty for each 30-day period or fraction thereof, beyond the due date, up to a maximum of 25% in addition to the delinquent amount due. In addition, pursuant to Section 364.285, Florida Statutes, the Commission is authorized to impose upon any entity subject to its jurisdiction a penalty of not more than \$25,000 for each offense, if such entity is found to have refused to comply with or to have willfully violated any lawful rule or order of the Commission, or any provision of Chapter 364.

Utilities are charged with knowledge of our rules and statutes. Moreover, it is general Commission practice that all utilities that apply for **Interexchange Telephone** certificate receive a copy of all applicable rules. Further, in accordance with Section 364.335, Florida Statutes, as part of the application process, utilities provide an affidavit indicating that they have read and understood the applicable rules.

If you wish to request another form, please contact David Brown or Valorie Moore at the number below. The payment should be identified with the company code and the company's name. Failure to provide payment within 15 days of this notice will result in the establishment of a docket to address your failure to return the RAFs form and pay RAFs in accordance with Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code. As specified above, pursuant to Section 364.285, Florida Statutes, the Commission may impose a fine or cancel your certificate. Therefore, it is important that you address this matter now.
