Dear Ms. Isler:

As we discussed earlier today, please be advised that Advanced TelCom, Inc.'s Interexchange Company Regulatory Assessment Fee Return for calendar year 2003 (the "Return"), which Return was due to be filed with the Florida Public Service Commission ("FPSC") on or before January 30, 2004, is enclosed herewith. We realize that the Return is being filed late and apologize for having missed the filing deadline.

In addition to the Return, we are enclosing a check in the amount of \$568.50 made payable to the FPSC. That amount covers the \$68.50 due to the FPSC with the Return (which includes the \$50.00 minimum charge, plus penalties and interest). In addition to the regulatory fee, the check also includes a settlement amount of \$500.00. We hereby request that the FPSC accept this additional \$500.00 amount as settlement of the above-captioned docket (No. 040978-TI).

We understand that regulatory returns and fees are due no later than January 30th of each year. Moreover, we also understand that even though we are in the process of selling Advanced TelCom, Inc. in a stock sale, the return for revenues received in calendar year 2004 and the regulatory fees on those revenues will be due to the FPSC by January 30, 2005. We have included the Interexchange Company Regulatory Assessment Fee Return on a regulatory filings spreadsheet to give to the purchaser of Advanced TelCom, Inc. so that they will be aware of their obligations regarding filing of the return no later than January 30, 2005. In addition, I will personally discuss this issue with the purchaser's regulatory leader to make sure she is aware of this obligation.
