**Amendment to the Agreement
Between
EO Telecom, LLC
EO Telecom of Florida, LLC
and
BellSouth Telecommunications, Inc.
Dated January 2, 2004**

Pursuant to this Amendment, (the "Amendment"), BellSouth Telecommunications, Inc. ("BellSouth") and EO Telecom, LLC on behalf of itself and its certified operating affiliate, EO Telecom of Florida, LLC d/b/a EO Telecom (referred to as "EO Telecom") hereinafter referred to collectively as the "Parties," hereby agree to amend that certain Interconnection Agreement between the Parties dated January 2, 2004 ("Agreement") to be effective on the date of the last signature executing the Amendment ("Effective Date").

WHEREAS, BellSouth and EO Telecom entered into the Agreement on January 2, 2004, and;

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. The name of EO Telecom, LLC's certified operating affiliate, EO Telecom of Florida, LLC d/b/a EO Telecom, is changed to EO Telecom of Florida, LLC.
2. All of the other provisions of the Agreement, dated January 2, 2004, shall remain in full force and effect.
3. Either or both of the Parties are authorized to submit this Amendment to the respective state regulatory authorities for approval subject to Section 252(e) of the Federal Telecommunications Act of 1996.
