BellSouth Telecommunications, Inc. ("BellSouth"), pursuant to Rule 25-22.006, Florida Administrative Code, and Section 364.183, Florida Statutes, files this Request for Specified Confidential Classification.

1. On October 20, 2004, BellSouth filed its Response to Supra's Third Set of Interrogatories (Nos. 21-28), portions of which contain confidential business information.

In order for Staff to take possession of BellSouth's responses to Supra, on October 20, 2004 BellSouth also filed a Notice of Intent, in particular, for the attachment provided in BellSouth's Response to Supra's Third Set of Interrogatories, Item No.27 which contains confidential business, proprietary information.
