**BELLSOUTH TELECOMMUNICATIONS, INC.'S  
JOINT MOTION FOR EXTENSION OF TIME**

BellSouth Telecommunications, Inc. ("BellSouth") and Supra Telecommunications and Information Systems, Inc.'s ("Supra"), pursuant to Rule 28-106.204(5), Florida Administrative Code, requests that the Florida Public Service Commission ("Commission") grant the parties a (7) day extension of time or until November 19, 2004, in which to file their Rebuttal Testimony. In support of this motion, BellSouth states the following:

1. Pursuant to the Order Establishing Procedure, issued on September 22, 2004, Order No. PSC-04-0931-PCO-TP, Rebuttal Testimony is due on November 12, 2004.
2. BellSouth and Supra jointly request an additional week or (7) days to file their Rebuttal Testimony in the captioned docket.
3. Neither the parties nor Staff would be prejudiced by a (7) day extension of time and the January 6, 2005 hearing date should not be affected.

**WHEREFORE**, for the foregoing reasons, BellSouth and Supra respectfully request that the Commission grant the parties a (7) day extension of time or until November 19, 2004, in which to file their Rebuttal Testimony.




