



BELLSOUTH TELECOMMUNICATIONS, INC.'S AMENDED JOINT MOTION FOR EXTENSION OF TIME


BellSouth Telecommunications, Inc. ("BellSouth") and Supra Telecommunications and Information Systems, Inc.'s ("Supra"), pursuant to Rule 28-106.204(5), Florida Administrative Code, requests that the Florida Public Service Commission ("Commission") grant the parties an extension of time or until November 24, 2004, in which to file their Rebuttal Testimony. In support of this motion, BellSouth states the following:


1. Pursuant to the Order Establishing Procedure, issued on September 22, 2004, Order No. PSC-04-0931-PCO-TP, Rebuttal Testimony was due on November 12, 2004.
2. BellSouth and Supra jointly requested, on November 12, 2004, an additional week or (7) days or until November 19, 2004 to file their Rebuttal Testimony in the captioned docket. BellSouth withdraws this request and now asks that the parties be given until November 24, 2004 to file Rebuttal Testimony. The parties need the additional time to discuss and address recent events in the Supra bankruptcy proceeding and their impact of this case.
3. Neither the parties nor Staff would be prejudiced by this extension of time and the January 6, 2005 hearing date should not be affected.

WHEREFORE, for the foregoing reasons, BellSouth and Supra respectfully request that the Commission grant the parties this extension of time or until November 24, 2004, in which to file their Rebuttal Testimony and responses to discovery.


