

**SPRINT-FLORIDA, INCORPORATED'S MOTION  
TO ACCEPT TESTIMONY ONE DAY OUT OF TIME**

Sprint-Florida, Incorporated (Sprint) hereby files this Motion requesting that the Commission accept the Direct Testimony of Sandra A. Khazraee, which has been filed this day with the Commission Clerk via hand delivery, one day out of time. In support of this Motion Sprint states as follows:

1. The Order on Prehearing Procedure, Order No. PSC-04-1096-PCO-TL, required that direct testimony in this docket be filed on November 17, 2004.
2. Sprint erroneously attempted to file the testimony via electronic filing on November 17, 2004, contrary to the policies for electronic filing established by the Commission.
3. Sprint received notice from the Commission that the electronic filing was not accepted and, in response to the notice, on this same date has filed the original and 15 copies of the testimony via hand delivery to the Office of the Commission Clerk.
4. Simultaneously with the attempted electronic filing of the testimony, Sprint served the parties to this docket with electronic copies of the testimony and also has sent hard copies of the testimony via U.S. Mail. Therefore, no party


