



**BELLSOUTH TELECOMMUNICATIONS, INC.'S
AMENDED MOTION FOR EXTENSION OF TIME**

BellSouth Telecommunications, Inc. ("BellSouth"), pursuant to Rule 28-106.204(5), Florida Administrative Code, requests that the Florida Public Service Commission ("Commission") grant it an additional four (4) day extension of time or until December 17, 2004, in which to respond to the Motion to Dismiss filed by the Florida Competitive Carriers Association ("FCCA") and Competitive Carriers of the South ("CompSouth") in the above captioned docket. In support of this motion, BellSouth states the following:

1. On November 24, 2004, BellSouth filed a Motion for Extension of Time to respond to FCCA's and CompSouth's Motion to Dismiss the Petition to Establish Generic Docket filed by BellSouth Telecommunications, Inc. In its Motion BellSouth requested a (14) fourteen day extension of time or until December 13, 2004.
2. Because of the other hearing commitments, BellSouth needs additional time to adequately respond to the Motion to Dismiss.
3. FCCA and CompSouth would not be prejudiced by an additional four (4) day extension of time and the Commission would benefit from receiving an informed response to the Motion to Dismiss.

4. Counsel for the movants represented to BellSouth that the movants do not object to said extension of time.

WHEREFORE, for the foregoing reasons, BellSouth respectfully requests that the Commission grant it an additional four (4) day extension of time or until December 17, 2004 in which to respond to the Motion to Dismiss filed by the FCCA and CompSouth.
