

Dear Ms. Collins:

The Florida Public Service Commission received your letter dated September 14 requesting withdrawal of the company's IXC registration from the state. The Regulatory Assessment Fee (RAF) is applicable if a registration is active for any day during a calendar year. This means the 2004 RAF is applicable. The RAF is .0015% of a company's intrastate revenues or \$50.00, whichever is greater. Before staff can recommend a voluntary cancellation, the company must either pay the current year's RAF or provide a date certain it will be paid (such as 30 days after the Order is issued granting the cancellation). In addition, the effective date cannot be made retroactive, therefore, the effective date of the cancellation would be the date the Commission received your request (September 20, 2004).

Please review this information and let me know by October 15, 2004, how the company wishes to proceed. If you prefer to go ahead and pay the 2004 RAF, I can attach the 2004 RAF return via e-mail. Thank you.
