RE: Docket No. 041255-TI; Acknowledgment of registration as intrastate interexchange telecommunications company effective January 1, 2005, by Business Productivity Solutions a Minnesota Corporation, Inc., and acknowledgment of cancellation of IXC Registration No. TI162 by GE Business Productivity Solutions, Inc. d/b/a GE Capital Communications Services, effective December 31, 2004.

On October 26, 2004, this Commission received a letter from the company's attorney, Ms. M. Nicole Oden, advising GE Business Productivity Solutions, Inc. d/b/a GE Capital Communications Services was transferring its assets and customer base to Business Productivity Solutions a Minnesota Corporation, Inc., and requesting cancellation of GE Business Productivity Solutions, Inc. d/b/a GE Capital Communications Services' IXC tariff and removal from the IXC Registration List, effective December 31, 2004. Ms. Oden made a supplemental filing on November 19, 2004, which included the IXC Registration form and tariff for Business Productivity Solutions a Minnesota Corporation, Inc. and requested an effective date of January 1, 2005.

Staff has determined that GE Business Productivity Solutions, Inc. d/b/a GE Capital Communications Services has paid the 2003 Regulatory Assessment Fees and stated that the 2004 fee will be paid by the normal due date of January 30, 2005, as required in Section 364.336, Florida Statutes. If GE Business Productivity Solutions, Inc. d/b/a GE Capital Communications Services commences operations in Florida as an intrastate interexchange carrier in the future, a new registration must be filed.

As required by Section 2.07.C.5.i., Administrative Procedures Manual, GE Business Productivity Solutions, Inc. d/b/a GE Capital Communications Services, holder of IXC Registration No. TI162, has paid the required Regulatory Assessment Fee and can be removed from the IXC Registration list effective December 31, 2004.

In addition, staff has determined that Business Productivity Solutions a Minnesota Corporation, Inc.'s documents meet the requirements of Section 364.02(13), Florida Statutes. Business Productivity Solutions a Minnesota Corporation, Inc. is now assigned TJ965 as its IXC Registration Code for the State of Florida. Pursuant to Section 364.02(13), Florida Statutes,
