Pursuant to the provisions of Section 367.045, Florida Statutes, and the provisions of Florida Public Service Commission Rule 25-30.036(2), Notice is hereby given this 25th day of November, 2004 by Mad Hatter Utility, Inc., 2348 Raden Drive, Land O' Lakes, Florida 34669, of its Application to extend its service area to provide water and wastewater service to the following described lands in Pasco County, Florida:

Parcel 1
A portion of the North 696 feet of the West 437.5 feet of the North West 1/4 of the Northeast 1/4 of section 32, township 26 South, range 19 East, Pasco County, Florida, bounded and described as follows: Commence at the Northeast corner of said tract and run South 396 feet for a point of beginning; thence from said point the following six (6) courses:
