
NOTICE OF NAME CHANGE AND CONSOLIDATION

Pursuant to request by staff, MCImetro Access Transmission Services, LLC and Intermedia Communications, LLC hereby notify the Commission of the following information in the above-referenced dockets.

The Intermedia certificate is in the name of Intermedia Communications, Inc., but as a part of MCI's emergence from bankruptcy, the corporate name was changed to Intermedia Communications, LLC, with the Florida Secretary of State's Division of Corporations.

Further, as part of MCI's emergence from bankruptcy, Metropolitan Fiber Systems of Florida, Inc. (MFS) was consolidated into MCImetro Access Transmission Services, LLC. Subsequently, MCI has notified the Florida Secretary of State that MFS is no longer doing business in the state of Florida. MCImetro Access Transmission Services, LLC, is the successor in interest to the interconnection agreement between MFS and Verizon Florida Inc.
