Sun Tel North America, Inc. has divested substantially all of its pay telephone assets and business and does not intend to operate or maintain any pay telephones in the State of Florida, nor to otherwise engage in any pay telephone services in the State of Florida, hereafter. The sale of Sun Tel North America, Inc.'s Florida pay telephones occurred during November 2004.

Accordingly, enclosed for early filing is Sun Tel North America, Inc.'s Pay Telephone Service Provider Regulatory Assessment Fee Return for calendar year 2004, together with a check in the amount of \$77.19 in payment of the assessment fee required thereby. Additionally, enclosed is a corrected Change of Information on Regulated Utility form reflecting only our New York location and mailing address.


In light of the foregoing, Sun Tel North America, Inc. respectfully requests the following:
