


This is in response to Order No. PSC-04-1198-PAA-TI issued on December 3, 2004 in Docket No. 040986-TI. Please consider this a protest and/or an offer of settlement to resolve this docket.

Nigerian-American Investment Corporation d/b/a NAIC Telecommunications registered as an IXC carrier on December 31, 2003, and understands this docket was established for nonpayment of the 2003 Regulatory Assessment Fee. The company did not have any revenues for that one day in 2003 and was under the impression that the fee was not applicable. The company is now aware that if a certificate is active for any day during a calendar year, the Regulatory Assessment Fee is owed for that year by January 30th of the subsequent year. The 2003 fee, plus statutory late payment charges, was paid on December 23, 2004.


