As you know, I have expressed interest in being considered for the General Counsel position at the Commission when Harold McLean retires on November 1st.



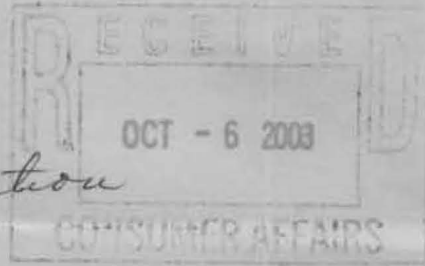
