

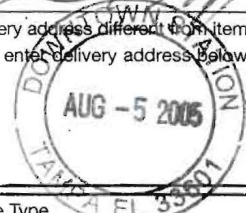

I briefly reviewed the materials sent to me yesterday. In short and without a full analysis, I am of the opinion that this is an internal transfer of assets between two related companies that has little or no effect as to their managerial or technical skills (ie., their ability to provide telecommunications in Fl).
