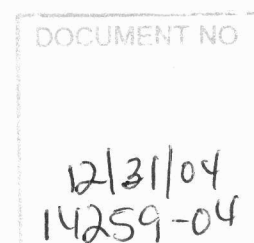

## **Alternative Language**

- (13) Local providers shall ensure a local freeze is lifted within 24 hours, except for resale and UNE-P local providers. Resale and UNE-P local providers shall ensure that a local freeze request is submitted to the underlying local provider within 24 hours of receiving a request to lift the local freeze. The underlying local provider shall provide confirmation of the local freeze lift to the resale or UNE-P local provider within 24 hours.
