

Pursuant to our prior commitment, I am providing to you and all other parties to this proceeding our status report of activities concerning the transfer of the water and sewer plants from Zellwood Station Cooperative to Orange County for the month of December. During the month of December, a new draft of the Orange County/Zellwood asset purchase agreement was produced and is currently under review for final comments by Zellwood, Orange County and the City of Apopka. The new draft agreement implements the agreed plan among Zellwood, Orange County and Apopka to have Apopka utilize capacity in its treatment and supply facilities to provide the wholesale water and wastewater services to Zellwood after the closing between Zellwood and Orange County.
