Good Morning,

I need to modify my instructions to you regarding your inquiry that follows: We received money for TJ153 and tx236 an a settlement payment for \$1000.00. Docket number 040846. How would you like me to handle this?

I misunderstood your inquiry. I did not realize that the \$1000 payment only applied to TX236, which equates to Docket 040846-TX. Apparently there were two letters from the same company. The \$1000 is a full payment of the penalty. Thus, you will need to modify the records such that of the \$1000 in Docket 040846-TX, \$200 goes to the Commission's Trust Fund (which you call recovery cost) and \$800 goes to the General Revenue Fund (which you refer to as fines). Docket 040846-TX can be closed as there was no settlement offer, just payment of the fine. The company failed to respond to the PAA Order, but did pay the fine within the time alloted by the consummating order (e.g., 14 days).

Regarding TJ153, which equates to Docket 040904-TI, there was a separate piece of correspondence from the company that offered a settlement offer of \$400. In this case, Paula will be taking a recommendation to Agenda to either deny or accept the settlement. Thus, all prior instructions about half of the \$1000 applying to this docket are not valid. This docket will remain open. The company did timely respond to the PAA Order.
