<u>Issue 2</u>: Should the Commission grant OPC and FIPUG's joint request to strike or dismiss FPL's Preliminary Surcharge Petition?

<u>Recommendation</u>: No. The Commission should deny OPC and FIPUG's joint request to strike or dismiss FPL's Preliminary Surcharge Petition.

Commissioner Danidson dissented on this issue.

<u>Issue 3</u>: Should the Commission authorize FPL to implement a preliminary storm surcharge subject to refund? <u>Recommendation</u>: Yes. FPL should be authorized to implement a preliminary surcharge, subject to refund. This approval would be preliminary in nature and would not prejudge the merits of any issues that may be raised in the evidentiary hearing in this docket, such as the implementation of any surcharge, any amounts to be recovered, or the duration of any surcharge.

<u>Issue 4</u>: Should the Commission approve FPL's proposed Original Tariff Sheet No. 8.033? <u>Recommendation</u>: If the Commission approves staff's recommendation in Issue 3, the preliminary surcharge tariff as filed should be approved and remain in effect until the final order is issued in this docket. The appropriate allocation of the costs to rate classes and the resulting rate factors should be an issue in the hearing scheduled for April. The tariff should become effective for meter readings on or after February 17, 2005. If the Commission denies FPL's request to implement the storm damage surcharge subject to refund prior to the hearing, the proposed tariff sheet should be suspended, pending the results of the scheduled hearing.
