Dear Mr. Hodges:

By letter dated September 27, 2004, you indicated that Sunshine Utilities of Central Florida, Inc., would not proceed with its Regional Water System project. Accordingly, staff filed its recommendation to close the docket noting that the utility had indicated it would not proceed with the project.

However, before that recommendation could be considered, the utility requested and was granted a deferral of that item until the March 1, 2005 Agenda Conference. The reason given for the deferral was that Marion County had contacted the utility and indicated that it would like to discuss other options for the project before the docket was closed.


