This is in response to Order No. PSC-04-1271-PAA-TC issued on December 23, 2004 in Docket No. 040991-TC. Please consider this an offer of settlement to resolve this docket.

Daytona International Speedway, Inc. was granted Pay Telephone Certificate No. 543 on January 28, 1986. Through an oversight, the 2003 fee was not paid.

The company's 2003 Regulatory Assessment Fee, including statutory late payment charges for the years 1998, 1999, 2000, and 2003 has been paid in full. To resolve this docket, the company respectfully requests that the Commission accept its proposal to pay future Regulatory Assessment Fees by January 30th of every year and proposes a settlement in the amount of \$83.00 in lieu of the \$500 fine imposed.
