I would like to highlight some things for you, with hopes and dreams to hear something back from you soon. I have been sending this letter and other correspondence to different people pertaining to tragic events that I have been going through, since the year 2000.

Greg Sharp stayed in and out for a long time and became a very good friend that would come around and visit or speak often. He always was switching back and forth on different jobs and was not a permanent employee of this company, because there was not enough funding to support him here.

He stopped visiting in 2001, after Pop Star Aaliyah and Lisa Left Eye Lopez died alone with those tragic events on September 11, 2001, the terrorist attack on New York City. All these tragic events look directly focus to destroy my company and me personally, with this listening/Memory Device planted in my mouth.
