NOTICE OF ELECTION OF INTERCONNECTION AGREEMENT

In accordance with Sections 251 and 252 of the Communications Act of 1934, as amended by the Telecommunications Act of 1996 (the "Act"), 47 U.S.C. §§ 151 *et seq.*, KMC Data LLC ("KMC Data") hereby files its Notice of Election of Interconnection Agreement between BellSouth Telecommunications, Inc. ("BellSouth") and Global NAPS, Inc. ("Global NAPS") for the State of Florida and respectfully requests that the Florida Public Service Commission (the "Commission") enter an order acknowledging the adoption of the interconnection agreement, effective as of December 6, 2004. In support hereof, KMC Data states as follows:

KMC Data elects to receive interconnection services in accordance with the terms of the interconnection agreement between BellSouth and Global NAPS (the "Global NAPS Agreement"), as approved by the Commission on June 21, 2004 in Docket No. 04-0241. On December 6, 2004, KMC Data notified BellSouth by letter of its intent to adopt the Global NAPS Agreement, but has been unable to reach agreement with BellSouth with regard to certain terms for the adopted agreement. Accordingly, KMC Data is exercising its adoption rights under the Act by making this filing directly with the Commission. A copy of the adoption notice to
