

NOTICE OF MERGER


Pursuant to a request by Staff, MCImetro Access Transmission Services, LLC (“MCImetro”) and Intermedia Communications, LLC (“Intermedia”) hereby notify the Commission of the following information in the above-referenced dockets.

The Intermedia CLEC certificate is in the name of Intermedia Communications Inc., but as part of the emergence of MCI, Inc. (“MCI”) from bankruptcy, Intermedia Communications, Inc. was merged into Intermedia Communications, LLC and notification was provided to the Florida Secretary of State’s Division of Corporations.

Further, MCI, on behalf of its subsidiaries Intermedia and MCImetro, has notified the Commission of the corporate merger of Intermedia into MCImetro, which was undertaken to streamline MCI’s corporate structure, including the transfer of Intermedia’s telephone assets and the cancellation of Intermedia’s certificate of public convenience and necessity. The requested effective date of the merger is December 31, 2004, and the matter is pending before the Commission. When finalized by the Commission,

MCImetro will be the successor in interest to the interconnection agreement between Intermedia and BellSouth Telecommunications, Inc.


