COMMENCE AT THE NORTHWEST CORNER OF GOVERNMENT 1, SAID SECTION 21; THENCE EASTERLY ALONG THE NORTH LINE OF SAID SECTION 21 TO THE WESTERLY RIGHT OF WAY LINE OF STATE ROAD A1A; THENCE SOUTHERLY ALONG SAID WESTERLY RIGHT OF WAY LINE 1413 FEET, MORE OR LESS, TO THE NORTH LINE GOVERNMENT LOT 4 SAID SECTION 21 AND THE POINT OF BEGINNING; THENCE SOUTHERLY ALONG THE RIGHT OF WAY A DISTANCE OF 400 FEET TO A POINT; THENCE WESTERLY AND PARALLEL WITH THE NORTH LINE OF SAID LOTS 3 AND 4, A DISTANCE OF 800 FEET TO A POINT; THENCE NORTHERLY AND PARALLEL WITH THE SAID WEST BOUNDARY OF SAID RIGHT OF WAY, DISTANCE OF 400 FEET TO A POINT ON THE NORTH LINE OF SAID LOTS 3 AND 4; THENCE EASTERLY ALONG THE NORTH LINE OF SAID LOTS 3 AND 4 TO THE POINT AND PLACE OF BEGINNING.
