3. IDS is a telecommunications company that has been certificated by the Commission as a competitive local exchange telecommunications company (CLEC) and an interexchange company (IXC) in Florida. As such, IDS is subject to the rules, regulations and orders of the Commission, and such rules, regulations and orders impact IDS' ability to provide local exchange telecommunications service and intrastate interexchange telecommunications service.

4. In this docket, the Commission will review BellSouth's current hot cut process and determine its sufficiency as well as determine what additional processes must be made available to CLECs. The Commission will also review and set rates for such processes.
