

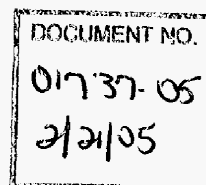

Representative**


