Pursuant to Order No. PSC-05-0104-SC-SU, issued 1/26/05, the Commission proposed to fine the above-noted utility in the amount of \$500 for apparent violation of the requirements of another order unless the utility responded by February 16, 2005. Failure to respond by that date resulted in the fine being deemed imposed. The utility failed to respond by that date and it is my understanding that you have now received a check in the amount of \$500. That was the total amount of the fine and Order No. PSC-05-0104-SC-SU was consummated by Order No. PSC-05-0192-CO-SU, issued 2/21/05, which order also closed dockets nos. 020331-SU and 020439-SU.
