ITC^DELTACOM COMMUNICATIONS, INC., d/b/a ITC^DELTACOM**


ITC^DELTACOM COMMUNICATIONS, INC., d/b/a ITC^DELTACOM ("ITC"), pursuant to Rule 25-22.006, Florida Administrative Code, files its Motion for Extension of Duration of Orders Granting Confidential Classification, and as grounds in support thereof the following:

1. On August 28, 2003, the Commission issued Order No. PSC-03-0974-CFO-TL Granting ITC's Request for Specified Confidential Classification for Document No. 07351-03 (cross-reference 07936-03 and 07939-03).
2. The reasons ITC asserted in support of its Request for Specified Confidential Classification continue to exist and pertain to the information. Specifically, there is still a need to protect proprietary business information and information which is not subject to public disclosure.
3. Due to an inadvertent oversight, ITC is filing this motion for an extension four weeks late. However, the information requested remains in the confidential possession of Commission Staff.
