The Florida Public Service Commission will consider at its April 5, 2005, Agenda Conference, Docket No. 050082-GU, Application of Florida City Gas, a Division of Pivotal Utility Holdings, Inc., formerly NUI Utilities, Inc., for authority to issue debt security, pursuant to Section 366.04, Florida Statutes, and Chapter 25-8, Florida Administrative Code.
