
Dear Ms. Bayo:

**TAMPA ELECTRIC COMPANY'S REPORT  
ON STATUS OF TERRITORIAL AGREEMENT BETWEEN  
TAMPA ELECTRIC COMPANY AND SUMTER ELECTRIC COOPERATIVE, INC.**


In Order No. PSC-94-1397-FOF-EU issued on November 16, 1994 in Docket No. 940947-EU the Commission approved the territorial agreement entered into by and between Tampa Electric Company and the Sumter Electric Cooperative, Inc. Section 4.1 of said agreement calls for an annual report from Tampa Electric Company providing the status of the agreement and any modifications proposed in the agreement.

This is to advise the Commission that the subject territorial agreement remains in full force and effect and that no modifications have been proposed in such agreement nor have the parties encountered any disputes concerning the provisions of such agreement.
