As the Commission is aware, Teligent recently entered into an agreement with Startec Global Licensing Company ("Startec") whereby Startec acquired Teligent's Florida long distance assets, which comprised its long distance customer base and associated customer account information. The parties closed the transaction on December 31, 2004. Since the close of this transaction, Teligent has ceased to operate in Florida and as such, wishes to voluntarily surrender its Florida Certificates.
