
**AMENDED NOTICE OF INTENT TO  
REQUEST CONFIDENTIAL CLASSIFICATION**

Progress Energy Florida, Inc. ("PEF" or the "Company"), pursuant to Section 366.093, Florida Statutes, and Rules 25-22.006, Florida Administrative Code, hereby files this Amended Notice of Intent to Request Confidential Classification of documents to be produced to the Commission in response to the Commission's "Document Request 1" in this matter. On February 23, 2005, the Public Service Commission issued a letter initiating a Focused Electric Service Quality Review of PEF. In response to the Commission's document request that was included as part of its initiation letter, PEF submitted copies of various audits/studies to the Commission in response to Request 3 therein. Those audits/studies contain "confidential information" as that term is defined in Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, and are thus entitled to confidential classification under those provisions. Accordingly, PEF filed a Notice of Intent to Request Confidential Clarification regarding those documents on March 15, 2005. Subsequent to filing that notice, the Commission Staff requested additional documents regarding document Request 1 that are also confidential and PEF will be providing those documents as requested. Pursuant to Rule 25-22.006(3)(a)(1), therefore, PEF will file a Request for Confidential Classification for the additional
