**Amendment to the Agreement  
Between  
Global Connection Inc. of America  
and  
BellSouth Telecommunications, Inc.  
Dated May 31, 2004**

Pursuant to this Amendment, (the "Amendment"), Global Connection Inc. of America ("Global Connection"), and BellSouth Telecommunications, Inc. ("BellSouth"), hereinafter referred to collectively as the "Parties," hereby agree to amend that certain Interconnection Agreement between the Parties dated May 31, 2004 ("Agreement") to be effective thirty (30) calendar days after the date of the last signature executing the Amendment ("Effective Date").

WHEREAS, BellSouth and Global Connection entered into the Agreement on May 31, 2004, and;

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. Delete reference to "Attachment 2 – Network Elements and Other Services" in the Table of Contents.
2. Delete reference to "Network Elements and Other Services" in Section 31.2 of the General Terms and Conditions.
3. Delete Attachment 2, Network Elements and Other Services, in its entirety
4. All of the other provisions of the Agreement, dated May 31, 2004, shall remain in full force and effect.
5. Either or both of the Parties are authorized to submit this Amendment to the respective state regulatory authorities for approval subject to Section 252(e) of the Federal Telecommunications Act of 1996.
