Indiantown Company, Inc. is scheduled to have the Commission consider the Staff's recommendation on final rates at the April 19, 2005 Agenda Conference.


The company would like to defer the matter until June 14, 2005, at the latest, or May 17, 2005, if Staff is prepared to move forward at the earlier date. The deferral request is for the purpose of allowing the company to provide further information about the expense of sludge removal for Staff's review.
