On February 17, 2004, Docket No. 040139-TI was established to address Telecommunications Resources, Inc.'s (TRI) failure to remit Regulatory Assessment Fees (RAFs) for the years 2003 and 2004. By Order No. PSC-04-0351-PAA-TI, issued April 5, 2004, the Commission approved the cancellation of TRI's Interexchange Telecommunications Registration No. TI205. The Commission further ordered that the outstanding RAFs and penalty and interest charges not be sent to the Department of Financial Services for collection, but instead, that the Division of the Commission Clerk and Administrative Services should request permission to write off the uncollectible amounts.

Therefore, staff requests that the Bureau of Administrative Services/Fiscal Services Section take the appropriate steps to seek permission from the Department of Financial Services to write off the uncollectible RAFs for the year 2003 and the uncollectible penalty and interest charges for 2001 and 2002 for TRI.
