According to our records, Colony Park Utilities, Inc. has failed to file its 2004 Annual Report or request an extension as required by Rule 25-30.110(3), Florida Administrative Code (F.A.C.). The due date for the filing of the 2004 Annual report was March 31, 2005. You were notified of this deficiency by facsimile on March 31, 2005. Rule 25-30.110(6), F.A.C., sets penalties for noncompliance with the annual report requirement. The applicable penalty for a Class C utility is \$3.00 per day and is based on the number of calendar days that have elapsed from the due date until the date of filing. Please submit a payment of \$39.00 by check made payable to the Florida Public Service Commission for the amount of the penalty.
