According to our records, Gator Utilities has failed to timely file its 2004 Annual Report or request an extension as required by Rule 25-30.110(3), Florida Administrative Code. The due date for the filing of the 2004 Annual Report was March 31, 2005. You were notified of this deficiency by a courtesy phone call during the week of the actual due date of March 31, 2005. Rule 25-30.110(6) and (7), F.A.C., sets penalties for noncompliance with the annual report requirement. The applicable penalty for a Class C utility is \$3.00 per day and is based on the number of calendar days elapsed from the due date until the date of filing.
