

1. On February 25, 2005, STS filed a Notice of Intent to Request Specified Confidential Classification pursuant to Rule 25-22.006(3)(a), Florida Administrative Code.
2. Upon review of all filings, STS has determined that the information it desires to keep confidential are all documents contained on the compact disc which were submitted as BellSouth's Exhibits to the Affidavit of Cynthia A. Clark, which is was attached to BellSouth's Motion For Summary Final Order, filed on or about February 14, 2005.
3. The information contained on the compact disc which were submitted as BellSouth's Exhibits to the Affidavit of Cynthia A. Clark contain customers' private and confidential information.
4. The information contained on the compact disc which were submitted as BellSouth's Exhibits to the Affidavit of Cynthia A. Clark contain competitive business information. This information is valuable, it is used by STS in conducting its business and STS strives to keep it secret. Therefore, such


information is a trade secret which should be classified as proprietary, confidential business information pursuant to Section 364.183(3)(e), Florida Statutes and is exempt from the Open Records Act.

5. Public disclosure of the Attachments would provide STS's competitors with an advantage in that they would know STS's trade secrets. The data is valuable to competitors and potential competitors in formulating strategic plans for entry, pricing, marketing, and overall business strategies concerning these services. This same information on competitors is not available to STS. Disclosure of this data would impair the competitive business and cause harm to STS. Consequently, this information should be classified as proprietary, confidential business information pursuant to Section 364.183, Florida Statutes and is exempt from the Open Records Act.
6. The information discussed in this Request for Specified Confidential Classification is valuable, STS treats this business information as confidential in all requests, and this information has not been generally disclosed.
7. The original of this Request was filed today with the Division of the Commission Clerk and Administrative Services and a copy was served on the Parties.

WHEREFORE, based on the foregoing, STS respectfully requests that, pursuant to Section 364.183, Florida Statutes, the Commission enter an order declaring the information described above to be confidential, proprietary business information that is not subject to public disclosure.


