As we discussed over the telephone recently, the staff has reviewed the information contained in Appendices A and B to Exhibit A that FPL filed in conjunction with its transmission line need determination petition. You have requested confidential classification for the appendices, which contain detailed load-flow analyses and related information filed in compliance with the requirements of Commission Rule 25-22.076, Florida Administrative Code.
