On December 14, 2004, FirstEnergy Corp. ("FirstEnergy"), First Communications LLC ("First"), and McKinley Communications, LLC ("McKinley") filed a Notification with the Florida Public Service Commission ("Commission") regarding a transaction resulting in a change in ownership of First. This letter advises the Commission of the completion of the transaction that was subject to the Notification. McKinley now holds a 51% ownership interest in First, FirstEnergy holds a 31.85% ownership interest in First, and Boich¹ holds the remaining 17.15% ownership interest in First.


