Enclosed are the following revised rate schedules in quadruplicate for the Commission's approval:

Rate Schedules L, FL, & RSL

The Rate Schedules are in both administrative and final format.

Clay Electric's Board of Directors at a regular Board meeting held April 28, 2005 approved these changes. The revised rate schedules are scheduled to be effective July 1, 2005.

These rates have been modified to reflect today's higher power cost adjustment factor. When the rates were last revised in May 2000 the PCA was (\$0.00500) per kWhr. Today our PCA is \$0.00780 per kWhr. The attached spreadsheet shows the rate impact. We have also modified or added language to the rate schedules more clearly defining our Terms of Service, Limitation of Service, and Rules and regulations.

The Cooperative shall repair or replace the lighting facilities during regular daytime working hours, Monday through Friday, as practicable after verification and subject to the Cooperative's current work schedules, emergency conditions, and the weather. The Cooperative does not warrant or guarantee that the service provided hereunder shall meet any lighting standard, including, but not limited to, the location of the facilities and the illumination provided. neither does the Cooperative guarantee or insure continuous and uninterrupted service.
