

BellSouth Telecommunications, Inc. ("BellSouth") files this Unopposed Motion for Extension of Time and says:


1. On April 29, 2005, FDN filed a Motion for Reconsideration¹ and an accompanying Motion for Oral Argument.

WHEREFORE, BellSouth respectfully requests an extension of time through and including Friday, May 13, 2005 in which the file a response to these Motions.


