**RE:** Correction in Docket Nos. 040464-TP, 041006-TP and 050075-TP

By letter received May 17, 2004, BellSouth Telecommunications, Inc. filed a request for approval of adoption, with modifications, of existing interconnection, unbundling, resale, and collocation agreement between BellSouth and The Other Phone Company, Inc. d/b/a Access One Communications and Talk America which was deemed approved by the Commission in Docket No. 020713-TP. WorldxChange Corp. d/b/a Acceris Communications Partners and d/b/a Acceris Communications Solutions adopted the interconnection, unbundling, resale, and collocation agreement approved by the Commission pursuant to Section 252(i) of the Telecommunications Act of 1996. Docket No. 040464-TP was opened to process this adoption.

BellSouth incorrectly cited Docket No. 020713-TP as the underlying agreement in the adoption, and that agreement was voluntarily withdrawn by BellSouth on October 7, 2002. The Company re-filed the agreement in Docket No. 030291-TP on March 21, 2003.

The correct agreement adopted in Docket No. 040464-TP is the one processed in Docket No. 030291-TP. The agreement between BellSouth and WorldxChange Corp. d/b/a Acceris Communications Partners and d/b/a Acceris Communications Solutions was amended in Docket Nos. 041006-TP and 050075-TP. This memorandum should be inserted in the docket file of all three Dockets.
