**CITY OF WILLISTON, FLORIDA'S
OBJECTION TO PROPOSED ORDER APPROVING
AMENDED TERRITORIAL AGREEMENT**

The City of Williston, a Florida Municipal Corporation, (the "City"), Post Office Drawer 610, Williston, Florida 32696 as a substantially interested person, and pursuant to Chapter 28 of the Florida Administrative Code, hereby objects to the proposed order approving an amended territorial agreement between Central Florida Electric Cooperative, Inc., ("CFEC"), and Progress Energy Florida, Inc., (the "Order"), stating as follows:


1. The substantial interest of the City may be affected by the Order because the City owns certain real property commonly known as the Williston Municipal Airport, which real property lies within the municipal corporate boundaries of the City, and which real property has been included in the territory claimed by CFEC under the amended territorial agreement. A map depicting the Williston Municipal Airport is attached as Exhibit "A".
2. The City does not agree that the Williston Municipal Airport real property lies within the CFEC electric service territorial boundary.

3. Although not a party to these proceedings or to the amended territorial agreement, the City has received notice of the proposed Order, and the City's failure to object to the proposed order could be construed as acquiescence to CFEC territorial claim.



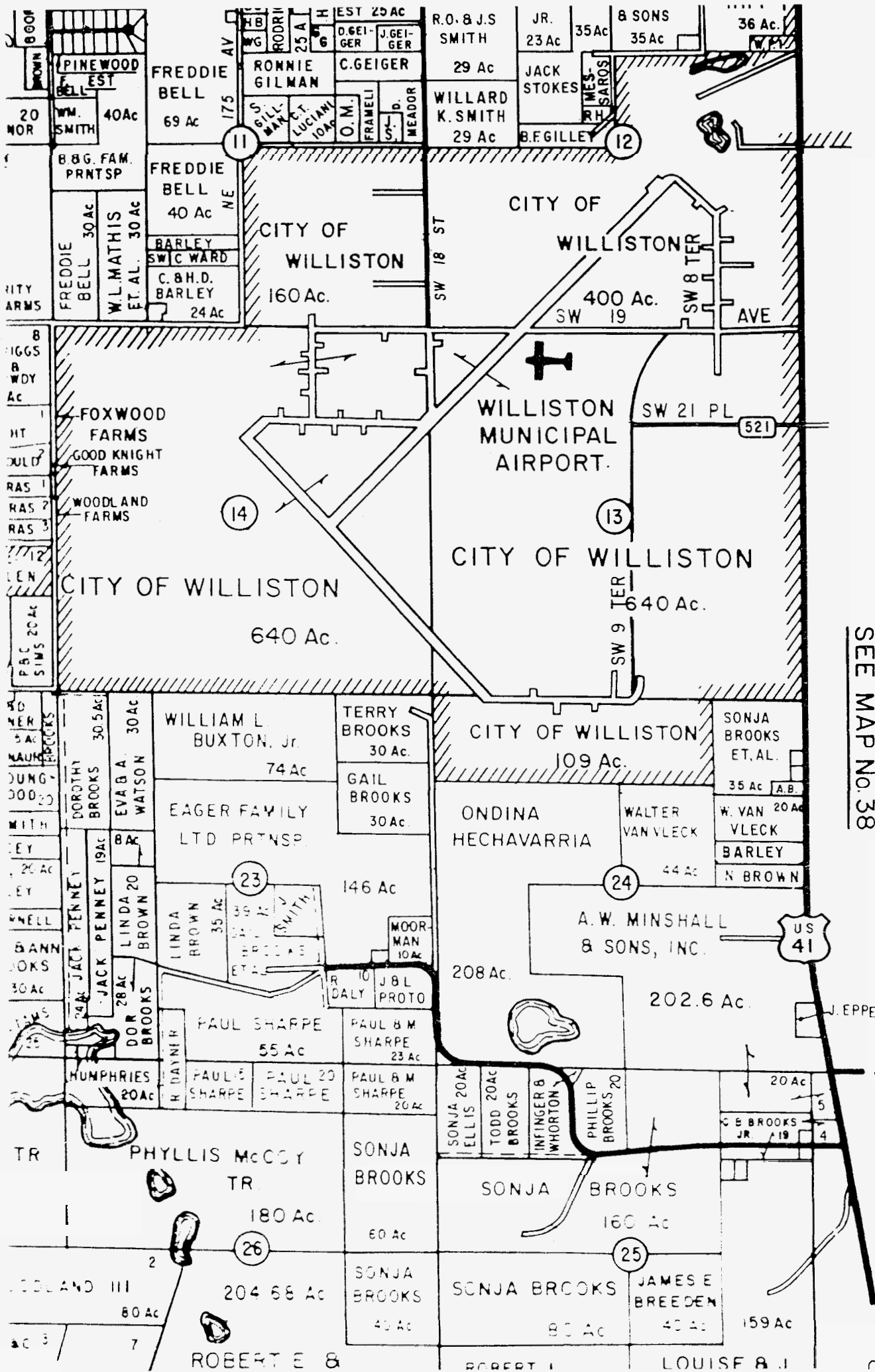
