Sprint Communications Company Limited Partnership ("Sprint") hereby files this response to the Joint Motion Requesting Procedural Notice filed by BellSouth Telecommunications, Inc. ("BellSouth") and the Competitive Carriers of the South, Inc. ("CompSouth"), hereinafter referred to as "Joint Movants," on May 6, 2005.


1. The Joint Movants have requested that the Commission issue an order making all competitive local exchange companies (CLECs) to whom BellSouth had sent a change in law notice, relating to the changes in law that are the subject of this proceeding, parties to this proceeding. In addition, the Joint Movants request the Commission to order that these CLECs are bound by the outcome of this proceeding regardless of whether they choose to actively participate.
2. Sprint does not object to the Commission exercising its authority under Rule 28-106.109, F.A.C., to notify all persons whose substantial interests might be affected by a pending proceeding to give them an opportunity to intervene (which

Sprint presumes to be the Commission's authority to issue the order requested by the Joint Movants).

3. However, Sprint is concerned, should the Commission grant the Motion and order that all noticed CLECs are bound by the Commission's decision, that the Commission make clear that the decision will not supersede the terms of any amendment addressing the issues that are the subject of this proceeding that otherwise may be or may have been mutually agreed to by the parties.

WHEREFORE Sprint requests that should the Commission grant the Joint Motion, the Commission make clear in its order that the outcome of the proceeding will not supersede the terms of any amendment addressing the issues that are the subject of this proceeding that otherwise may be or may have been mutually agreed to by the parties.


