

- A. Whether Z-Tel's adoption of the Network Telephone Agreement in its entirety was within Z-Tel's statutory rights under section 252(i) of the federal Communications Act, 47 U.S.C. §252 (i)?
- B. Whether Z-Tel's decision to adopt an existing interconnection agreement at the expiration of their prior agreement was reasonable?
- C. Whether anything in section 252(i) or the FCC's implementing rules precluded Z-Tel's ability to adopt the Network Telephone agreement in its entirety?
- D. Whether Z-Tel adopted the Network Telephone Agreement within a reasonable period of time, as required by the Federal Communications Commission's rules, including 47 C.F.R. §51.809(c)?
