of the Commission, and such rules, regulations and orders impact STS's ability to provide local exchange telecommunications service in Florida.


4. STS has an Interconnection Agreement with BellSouth Telecommunications, Inc. ("BellSouth") on file with and approved by the Commission. In this proceeding, BellSouth proposes that the Commission consider certain changes to BellSouth's Interconnection Agreements with CLECs in Florida. Accordingly, the decisions which the Commission makes in this proceeding will substantially affect STS's interests.


