RE: Docket No. 050407-TL - Petition for expedited review of NXX-X code denial by North American Numbering Administration in Tallahassee exchange, by Sprint-Florida, Incorporated. *CRB*

On June 2, 2005, Sprint-Florida, Incorporated (Sprint), submitted a request to the Number Pooling Administrator (NeuStar) for additional numbering resources in the Tallahassee rate center, Calhoun Street (TLHSFLXADS0) switch, specifically one whole NXX. Also, on June 2, 2005, NeuStar denied Sprint's application because it did not meet the utilization criteria required for a new block of numbers.

On June 10, 2005, Sprint filed a petition requesting that the Commission overturn NeuStar's decision to deny numbering resources in the Calhoun Street (TLHSFLXADS0) switch, located in the Tallahassee exchange. In accordance with Commission Order PSC-02-0352-PAA-TL (Docket No. 020087-TL), which approved an expedited process for NeuStar code denials, we have examined the Sprint petition, along with the confidential supplemental information, and have determined the following:

- 1) The carrier has demonstrated that it has a customer in need of numbering resources;
- 2) The carrier has shown that it is unable to provide services to this potential customer because of NeuStar's denial of the numbering resources; and
- 3) The customer will not be able to obtain service from the provider of his/her choice because the carrier does not have the numbers available.

Since the three criteria of PSC-02-0352-PAA-TL have been met, please prepare an administrative Proposed Agency Action (PAA) Order to be issued within seven business days of this memorandum (June 29, 2005), as outlined in the expedited code denial process orders. NeuStar should be directed to provide Sprint the needed numbering resources to meet its customer's needs in the Calhoun Street (TLHSFLXADS0) switch specifically with one (1) NXX
